



APPLICATION AND CONTRACTUAL SERVICE AGREEMENT

An application and contractual service agreement for each art piece is required for Showcase consideration.

THIS CONTRACTUAL SERVICE AGREEMENT, DATED _____, 2017, BETWEEN:

The **C-THCC** agrees to:

1. Display and showcase any piece of art that is presented by the **ARTIST** and accepted by the Selection Team for submission to "A Day of Art";
2. Provide a venue for the presentation of such art work;
3. Promote ticket sales to the Saturday Showcase; and
4. Promote the event itself through website, TV and radio announcements to ensure the success of the event.

The **ARTIST** agrees to:

1. Create and supply a piece(s) of art, as described below, for the **C-THCC** "A Day of Art" Showcase, to be conducted on November 11, 2017;
2. Provide adequate frame, stand and any other requirement for the showing of the art piece(s)
3. Be present or be represented at the Cen-Tex Hispanic Chamber of Commerce Banquet Sneak Preview and Showcase to represent their art work;
4. Promote ticket sales to the Saturday Showcase; and
5. Provide a brief written description of the art piece being submitted for consideration (to include name of the piece (optional), dimensions in height and weight, and any other features:

SALES: The **ARTIST** agrees to the 70/30 split from all proceeds of art sales. The **ARTIST** will receive 70% of the revenue obtained from the sale of the art work and the **C-THCC** will recover the remaining 30%. All transactions will be accounted for by the **C-THCC** Accountant and revenue will be distributed to each **ARTIST** no later than two weeks after event.

TERMS: The terms of this Agreement will begin on the signature date of this Agreement and will remain in force and effect until the completion of "A Day of Art" and its ensuing requirements, to include compensation. Both parties agree to do everything necessary to ensure that the terms of this Agreement take effect.

RETURN OF PROPERTY: Upon the expiry or termination of this Agreement, the **C-THCC** will return to the **ARTIST** any property, documentation, records or confidential information which is the property of the **ARTIST**.

INDEMNIFICATION: Each party agrees to indemnify and hold harmless the other party, and its respective affiliates, officers, agents, employees, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses and cost of any kind or amount whatsoever, which result from or arise out of any act or omission of the indemnifying party, its respective affiliates, officers, agents, employees, and permitted successors and assigns that occurs in connection with this Agreement. This indemnification will survive the termination of this Agreement.

ENTIRE AGREEMENT: It is agreed that there is no representation, warranty, collateral agreement or condition affecting the Agreement except as expressly provided in this Agreement.

ENUREMENT: This Agreement will ensure to the benefit of and be binding on the Parties and their respective heirs, executors, administrators, successors and permitted assigns.

GOVERNING LAW: It is the intention of the Parties to this Agreement that this Agreement and the performance under this Agreement, and all suits and special proceedings under this Agreement, be construed in accordance with and governed, to the exclusion of the law of any other forum, by the laws of the State of Texas, without regard to the jurisdiction in which any action or special proceeding may be instituted.
